

Killuminati Vet Help Guidelines

The Killuminati Foundation will accept applications for assistance for dogs from any group, organization, or individual who is of legal age (18 years). We will also consider applications from rescues who are taking financial ownership for a dog (which otherwise would be euthanized) to medicate, rehabilitate, and adopt out to a new family for a second chance at a good life.

Applications - including the required pictures - must be submitted no later than 30 days after incurring the expense.

KF will provide monetary assistance toward non-routine medical expenses for dogs who are abandoned or rescued cases and for whom no other funding is available or is insufficient. Each application will be assessed individually. These guidelines will be followed to determine if the dog is eligible for assistance from the Killuminati Foundation:

Guidelines for Eligibility

1. The dog requires non-routine medical treatment. Such situation exists when a dog does not have a permanent home and has been taken in by an organized rescue group, shelter, vet clinic or in some circumstances by an individual rescuer.
2. It has been determined that no local rescue funds are available or are insufficient to provide the medical treatment required to bring the dog to a health status compatible with adoption.
3. Funds will not be provided for routine care such as immunizations, medications, heartworm preventative, testing for parasites, spaying/neutering, worming, baths, flea control, cost of food or boarding fees.
4. The dog must currently reside in Missouri. Or the dog must have been rescued from a Missouri shelter within the last 90 days. Proof of such rescue location and time frame must be submitted with original application.

5. A licensed veterinarian has assessed all injuries and ailments and has predicted that the dog has a solid chance for a good quality of life with treatment.
6. The dog has shown no signs of aggression toward other animals or humans.
7. The dog will be adoptable at the end of the treatment to be funded or will remain in the home of the family applying for aid.
8. The dog is not terminally ill.
9. There is no age limit for the dog in need - each case will be judged as to quality of future life for that dog.
10. No funds will be released without specific assurances that the dog is (or will be) spayed or neutered. This is the responsibility of the adopting family through their own finances or with the help of local rescue organizations.
11. The Killuminati Foundation will not fund the entire cost of treatment in any situation. The rescue/family is expected to pay AT LEAST HALF of the cost of treatment. *(The most the Killuminati Foundation will ever grant is UP TO HALF the treatment cost – but this does not guarantee that KF will grant the full half. Decisions of funding will be made based on availability and need.)*
12. Applications must include information directly from the veterinarian including the prognosis, diagnosis, breakdown of treatment/cost, vet history of dog including vaccination history and proof of spay/neuter.
13. Prior to release of funds, KF will verify costs/charges with the acting vet who gave the quote. KF may require receipts documenting these expenditures.
14. Individuals are welcome to apply for vet help, however, we can only consider one application per dog per year.
15. Licensed rescue organizations are welcome to apply for vet help. We will consider one application per rescue per quarter under the normal guidelines listed above. After the first approved application, any additional approved applications for that same quarter, will be granted up to \$100.

Once you've determined your dog meets our funding criteria, you may wish to submit an application or email us with any questions.

Application Procedures

The members of the Killuminati Foundation's Board will discuss the application, and may request additional information as needed to come to a decision. The Veterinarian of the case in question may be contacted as necessary to assist Board Members in making the funding decision.

KF will review all veterinary charges. Any misrepresentation of the facts or provision of false information about the case will result in immediate closure of the application and denial of funding for any future applications.

The Board will not vote on an application until pictures (either emailed or snail-mailed) of the dog or a face to face meeting are made possible. For all cases, discussion about the case will continue, and the Board will vote to grant or deny funding and to what amount. The application may be closed if pictures are not received within 30 days of receiving the application. This photo is primarily used to determine eligibility for funding. Pictures may also be used for documentation and may be used for promotional or fundraising the members of the KF board vote to fund an application, a check will be issued to the veterinarian providing the medical care.

If the dog is not approved for funding from the Killuminati Foundation will contacted the applicant by letter or email.

The applicant will be responsible for supervising final decisions on medical treatment, follow-up, fostering, spaying or neutering, and adoption.

The applicant must agree to be available for periodic contact from the Killuminati Foundation while treatment is ongoing and for a period of at least one year following completion of treatment.

In addition, information on rehoming of the dog should be provided to KF, including the name and address of the adopting person(s). Any necessary follow up treatment information should be available to KF for the duration of the dog's life. KF must be notified of the death of the dog and cause of death. The above information may be used to gather and maintain pertinent medical information.

The Board of Directors may vote to waive or delay any of the above requirements in the case of a pressing emergency situation. In those rare emergency cases when a vote is taken prior to a picture having been received, no funds will be issued until a picture has been made available. If the vote to fund has passed, and the picture shows a dog who does not meet our guidelines, the approval for funding may be withdrawn

The Killuminati Foundation uses pictures for documentation purposes and may use them in fundraising activities. Because of the difficulties in making a determination on each case, The Killuminati Foundation requires at least two pictures in order to consider funding. These pictures should include a clear frontal head shot and a full side body shot (including tail). There should be something in the picture (a person, for instance) that gives us a frame of reference on the size of the dog. Additional pictures may be required at the Killuminati Foundation's discretion. A good picture may mean the difference between getting an application approved or denied and a good picture will speed up the process. We cannot approve any dog for funding without pictures. If there is an injury or there is visual evidence of the medical issue, please be sure to include a photo of that.
